With the approval of the Competent Authority i.e. SEF Board of Governors and in pursuance of the Clause 8.1.7 of the Contract signed with the Partners under Promoting Private Schooling in Rural Sindh (PPRS) and SEF Assisted School (SAS) Programs, the Foundation is pleased to modify **Clause 11.1.3** of both the Contracts as under.

AMENDMENT

Existing Clause - 11.1.3:

The Foundation will offer a grant of up to PKR 500,000 for supporting costs of computer lab(s) equipment including computers; printers and other allied equipment or as approved by the BoGs from time to time for Elementary and Secondary schools.

Clause 11.1.3 is hereby amended and shall now be read as:

The Foundation may offer a matching/tied grant of up to PKR 600,000 for supporting costs of computer lab(s) equipment including computers; printers and other allied equipment or as approved by the BoGs from time to time for Elementary and Secondary schools provided the basic criteria to avail the grant is met.

In lieu of above, the School Partners shall provide the Equipment and the appropriate facilities as per the specifications provided by the Foundation to improve the standard of education as envisaged under the Contract and Appendix thereof. Provided, the provision of this Grant will remain subject to the fulfillment of pre-requisites to the issue of the grant(s).
