- Existing School Support Program (ESSP)
- SEF Middle & High School Program (SMHSP)

6. There shall be four (04) Assistant Directors with their support teams based at the Head Office, who shall coordinate with their respective Regional Heads on matters related to programs. They shall report to Director (P&P), SEF, through Deputy Director (Programs).
